5. Authored books may include up to **four** authors with academic research experience. In exceptional cases involving large interdisciplinary projects, additional authors may be considered subject to editorial/publisher approval.
6. For edited books and volumes, number of editors shall be limited to **three** and number of authors per chapter shall be limited to **five**. Additional authors and editors may be recruited subject to satisfactory justification for the same.
7. Editors should normally hold a Ph.D or MD/MS/DNB or equivalent degree **AND** have a minimum of five peer reviewed publications or must have prior experience in book publishing as an author/editor.
8. Editors are responsible for inviting and selecting contributors (authors) for edited volumes and for ensuring the academic competence and suitability of the participating authors.
9. If you do not have sufficient details of Table of contents yet, please enter as much information as possible based on present status.
10. All book proposals undergo an editorial assessment and may also be subject to peer review before a publishing decision is made.
11. Accepted proposals will be subject to a publishing agreement outlining editorial responsibilities, manuscript submission timelines, and copyright terms.
